# Council Reports:

# Mr. Humphries:

- 1. He went to the school board meeting last night. They are wrapping their books up for the end of the year. Financially everything seems to be going well. There is one more meeting left with the current superintendent, Dr. Vail. August 1<sup>st</sup>, the new superintendent, Mr. Fischer, will be taking over. Mr. Humphries said nothing against Mr. Vail, he believes the community involvement that the new superintendent has is going to be a game changer for the whole community. He is really excited about what he is going to bring to the table. He can't wait for that to happen.
- 2. Warren County Municipal League was last Wednesday. Good food, good company, good networking. He said the speaker was talking about how awesome Warren County is, which Mr. Humphries can't argue with that. Tourism, the reinvestment in ourselves, what we do it is amazing how every opportunity they have to double down on themselves, it comes back tenfold. He said we should be blessed to understand how awesome Warren County is compared to the other eighty-seven. He would put our county up against everybody in the state of Ohio, so there's something for you.
- 3. He wants to thank Veolia for the tour of the wastewater plant. He came away with a decent amount of information and lost a wager with a worker, Chad. He will go more into detail at the next council meeting. He is going to have to man up and drink some water.

#### Mr. Stivers:

1. He would like to wish everyone a happy Fourth of July, that is coming up before our next meeting.

- 2. On his way to work this morning, he happened to notice a bad wreck on I-75 North. There was a fatality. He wanted to pass his condolences to the family of the deceased and the truck driver.
- 3. This is motorcycle season, so he asks anyone who is driving a four-wheeled vehicle to look twice and save a life. On the other end of that spectrum, if you happen to have a motorcycle that does 0-60MPH in five seconds, that doesn't mean that you should. Mr. Stivers asked that riders to their part to stay safe and he will do his to keep them safe.

#### Mr. Bicknett:

- 1. They had their JEMS meeting. They are extremely close and are just waiting on the telephones to be installed with the extensions and the generator. They have temporary occupancy and they have started to move some things into the building to be prepared. Parts for the generator were shipped out to be delivered this week. As of right now, the generator is still two to three weeks out, which is the only piece they are waiting for to have full occupancy. Mr. Bicknell is hoping by the next council meeting he will be able to give a grand opening date to pass on to council and the citizens so that everyone can come out for it.
- 2. It has been extremely hot over the last week. He encourages the community to check on the elderly. It doesn't hurt to knock on a neighbor's door if you haven't seen them in a day or two making sure they're okay and that their air conditioner is running. Make sure they're safe. The last thing we want is for someone to feel like they don't have anybody.
- 3. Enjoy the summer. For kids there are a lot of bikes. He has seen a lot of people riding scooters and people running on Fairview Drive. With there not being any sidewalks, he recommends walking or jogging on the side where the cars are coming toward you so that you are able to see the car, as opposed to the other side where they are behind you. Please keep only one ear covered with music or radio so that you can hear a vehicle coming at you. This is the best and only way he knows for everyone to stay safe. Please be cautious, especially on those roads where we don't have sidewalks, yet.

#### Mrs. Kemper:

- 1. She would like to thank Mr. Lohr and Mrs. Geres for the business luncheon a couple of weeks ago. She said it was nice to have several business owners in our community come for the luncheon. The Lions Club opened the doors for us to use that room. Mrs. Geres did an awesome job along with Mr. Lohr and Chief Rogers just to explain to our businesses what is coming along. Especially the two new businesses that are coming to our community the coffee shop and business condos. It was exciting and nice to talk to all those businesses owners. Thank you very much for doing that.

- 3. As Mr. Humphries said, last week they had the Warren County Municipal League dinner at Hidden Valley. It was delicious food and a very hot evening, but it was nice. The President of the Warren County Convention Center and Business Bureau, Phil Smith, mentioned how large of an attraction we are here in Warren County. Within a thirty-mile radius, we are the only place in the state of Ohio where you can find more entertainment and more things to do, with King's Island, the campground, the tennis match coming to Mason and the new soccer fields that they put by Amoco Park. She said it was interesting to listen to him and if you get a chance you can go on their website for Warren County Ohio's Largest Playground. It lists all kinds of different entertainment and things you can go to. It is interesting.
- 4. On Tuesday July 16<sup>th</sup> at 6:00 p.m. at the Warren County Fairgrounds, in the Welcome Center, they are honoring all active-duty military and veterans with a free dinner for them and their family.

#### Manager's Report:

1. To add on to what Mrs. Kemper said about the business luncheon – it was a great event. Thanks to council and community members who were able to attend. Thank you to People's Bank who were able to help them put that on, especially Stephanie. She is great to work with. If you are a business owner who was not able to make it, and you still want to speak to someone at the city, please feel free to reach out to them. They will make time for you, anytime you need it.

- 2. They have finished promotion processes for Fire Lieutenant. They have three individuals who are going to be promoted: Dustin Perry, Corey Davis and James Whitney. Congratulations to them. That will replace Assistant Chief Beckett's position, which he left last year, and we are able to fill that with those three lieutenant positions. Mr. Lohr would like to do a swearing in for that, so he will get with the Chief and see if we can do that in July.
- 3. They are very close to filling the police officer opening they have had for a while. They made a conditional offer to a candidate. He is a certified federal law enforcement officer, and he will need to take the state OPOTA test to be certified in Ohio. Assuming he passes that, they will bring him on and be fully staffed again.

They have some residents who were impacted by the Duke Energy project, where they are upgrading their transmission lines and the poles associated with that. There are some residents who unfortunately are having to tear down fences, accessory structures, storage sheds and that sort of thing. This would waive the requirement for a permit fee and offset some of the burden there for these residents and is a nice thing to do for the residents.

The reason he is asking for this as an emergency is it seems like they are finalizing the work between the residents and Duke Energy. He had his first resident come in asking for a permit due to this work. He would like to get this passed so they can waive those fees as the residents come in.

Mayor Winkler clarified that the residents will still need to get a permit to ensure the work is done properly, they are just waiving the fee. Mr. Lohr agreed.
