## STREET LIGHTING ASSESSMENT

On May 14, 2024, the Carlisle City Council passed Resolution 14-24, declaring it necessary to provide for the lighting of the streets, lanes, and other public ways in Carlisle, Ohio. This special assessment, covering lighting services for 2023, will be included in the 2025 property taxes.

Residents can review an estimate of street lighting assessment costs by contacting the City Manager's office at 937-746-0555 ext. 210. Residents will have 14 days from the date of notice posting to submit a written objection, if necessary.

## **RESOLUTION NO. 14-24** CITY OF CARLISLE, OHIO

A RESOLUTION DECLARING IT NECESSARY TO PROVIDE FOR THE LIGHTING OF THE STREETS, LANES AND OTHER PUBLIC WAYS IN THE CITY OF CARLISLE, OHIO WITH ELECTRIC LIGHTING DURING THE YEAR 2023 AND AUTHORIZING THE ASSESSMENTS FOR THE COST AND EXPENSE THEREOF UPON ALL LOTS AND LANDS LYING AND BEING WITHIN THE CORPORATE LIMITS OF SAID CITY.

WHEREAS, it is necessary that the streets, lanes, and other public ways of the City of Carlisle, Ohio be lighted with electric lighting during the year 2023, and a part of the cost and expense of said lighting be assessed by a percentage of the tax value of the property to be assessed.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CARLISLE, OHIO THAT:

**SECTION 1:** 

It is hereby declared necessary that the streets, lanes and other public ways of The City of Carlisle, Ohio with above ground utility poles abutting the streets, within the corporate limits City of Carlisle, be lighted with electric lights during the year 2023.

**SECTION 2:** 

That 100% of the operational cost and 100% of capital expenditures of said street lighting shall be levied assessed by a percentage of the tax value of all property in the City of Carlisle, Ohio, which property is hereby declared and determined to be especially benefited thereby.

**SECTION 3:** 

That the assessment so to be levied on said benefited lands and lots shall be paid on one installment, in the manner provided for levying and collection of special assessments for street improvements.

**SECTION 4:** 

That the Finance Director is hereby authorized and directed to prepare the tentative special assessments against specially benefited property as herein described, as Exhibit A, and the Clerk of Council is hereby authorized and directed to serve notice of the passage of this resolution and filing of tentative assessments, in the manner prescribed by Section 727.14, Ohio Revised Code.

**SECTION 5:** 

This resolution shall take effect at the earliest date allowed by law.
